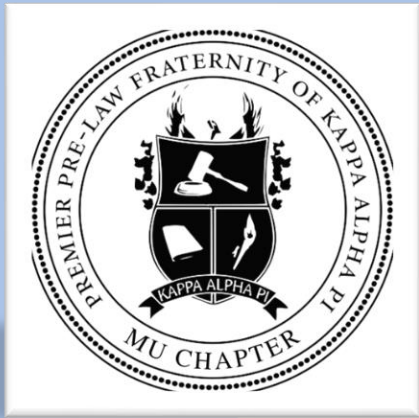

3 PRIMARY GOALS

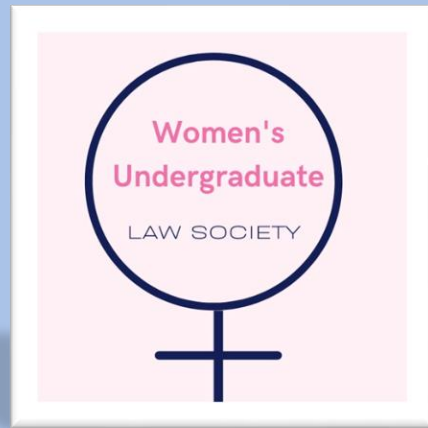
- 1) provide prelaw students insight into the legal world in regards to lobbying, legal review of the law, and gender inequality within the career field itself;
